Little Crooked Lake Special Assessment Proceedings
Excerpts of Minutes the of Special Meeting of the Township Board
held September 14, 2016 at the Silver Creek Township Hall.

Members Present: Supervisor Bill Saunders, Clerk Barbara Runyon, Treasurer Maureen Kuriata, Trustee Mike Glynn, Trustee Joel Moore

Members Absent: None.

The supervisor stated that the order of business was the consideration of the assessment roll for Little Crooked Lake Special Assessment District which had been prepared by the assessing officer of the township in accordance with Resolution R16-15 of the township board adopted August 10, 2016 and had been notified for public hearing of this date.

The township clerk reported that notices of the hearing on said assessment roll had been given by publication in the Dowagiac Daily News on August 31, 2016 and September 2, 2016 and by first-class mail to each property owner of record as shown on the assessment rolls of the township within the Little Crooked Lake Special Assessment District on August 24, 2016. Affidavits of such publication and mailings are on file with the township clerk.

The Clerk presented the proposed assessment roll which had been previously filed with her assessing a portion of the cost of the project on an annual basis and all persons present were invited to inspect the same and make comments with respect thereto. No one present commented or objected.

The public hearing was closed at 7:04 p.m. and the regular board meeting opened at 7:04 p.m.

RESOLUTION R16-16

RE: Little Crooked Lake Weed Control Special Assessment
Silver Creek Township, Cass County, Michigan

WHEREAS, the township board of the Township of Silver Creek, Cass County, Michigan, after due and legal notice, has conducted a public hearing upon a proposed assessment roll prepared by the assessing officer of the township for the purpose of treatment of aquatic evasion species incidental to the Little Crooked Lake Weed Control Special Assessment District, Silver Creek Township, Cass County, Michigan.

AND WHEREAS, such public hearing was preceded by proper notice in the Dowagiac Daily Newspaper of general circulation in the township, and by first-class mail notice to each property owner of record within said district upon said assessment roll;

AND WHEREAS, no one present at such public hearing concerning said assessment roll asked to be heard;

AND WHEREAS, no written objections were received to said roll and levy;

AND WHEREAS, the township board has duly inspected the proposed assessment roll and considered all comments thereto and has found the proposed assessment roll to be correct, just and reasonable;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. The assessment roll submitted by the assessing officer of the township shall hereafter be designated as Little Crooked Lake Weed Control Special Assessment District.
2. The assessment in said Silver Creek Township, Little Crooked Lake Weed Control Special Assessment District, shall be assessed on the 2016 winter tax bill (to be used in 2017) at the rate of \$141.21 per parcel unit, with each property owner receiving a credit in 2016 only of \$121.57 for each parcel due to a \$6,929.47 overage of the previous 5-year assessment being refunded. The net amount due in 2016 after the refund will be \$13.23. Special assessments in 2017, 2018, 2019 and 2020 will be at the rate of \$47.58 per parcel unit.
3. The assessments made in said special assessment roll are hereby ordered and directed to be collected by the township treasurer, and the township clerk shall deliver said special assessment roll to said treasurer with her warrant attached, commanding the treasurer to collect such assessment in accordance with the direction of the township board and said PA 188.

4. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be and the same are hereby rescinded.
