However, no official proposal has been submitted by Viking Properties yet, and they have not filed any paperwork with the state or township. They were present at the meeting to ask questions and seek advice from the board. Veronnica Kenrich suggested that they would need at least five acres for this type of project, while Mike Glynn added that they should also consider the availability of a well and sewer. Mark Davis raised a concern about the need for state approval, and Mike Glynn pointed out that campgrounds must be licensed by the state. The discussion revolved around the current regulations on campgrounds in the township and the necessary steps that Viking Properties will need to take if they decide to pursue their proposal. The potential impact of the project on the township was also discussed.
